Software End User License Agreement (EULA)

IMPORTANT - CAREFULLY READ THE FOLLOWING TERMS BEFORE DOWNLOADING AND USING THIS SOFTWARE. Throughout this Opto-3A Software License Agreement, you will be referred to as "You" or "Licensee," and the "Opto-3A" will be referred to as "Software."

TO DOWNLOAD AND INSTALL THE SOFTWARE YOU MUST AGREE TO THE FOLLOWING SOFTWARE LICENSE AGREEMENT THAT PERTAINS TO THE SOFTWARE FROM APOGEE ELECTRONICS CORP. THE SOFTWARE LICENSE AGREEMENT IS A LEGALLY BINDING CONTRACT THAT SHOULD BE READ IN ITS ENTIRETY.

It is your responsibility to ensure that any uses made of the Software comply with all applicable laws, including but not limited to intellectual property laws designed to govern the use of copyrighted works and other content accessible through the Software. You may also terminate the Software License by discontinuing use of all or any part of the Software and by destroying all of your copies of the applicable Software.

You may NOT:

- a. publish, display, disclose, rent, lease, modify, loan, distribute, or create derivative works based on the Software or any part thereof;
