End User License Agreement

GRANT OF LICENSE

In consideration of payment of the license fee, Entel Ltd. Inspired Acoustics division ("Entel") grants to you, the Licensee, a nonexclusive, nontransferable license to have one person use the enclosed Inspired Acoustics product (the "Product") on one personal computer at a time. If you want to use the Product on more than one personal computer at a time you must obtain separate licenses. All rights not expressly granted to Licensee are reserved to Entel.

OWNERSHIP AND USAGE OF THE PRODUCT

Entel and licensors of Entel own and will retain all title, copyright, trademark and other proprietary rights in and to the Product. Portions of the Product may incorporate certain material proprietary to third parties. This License is not a sale of the Product or any copy of it. You, the Licensee, obtain only such rights as are provided in this Agreement. You understand and agree as follows: you may not make any copies of all or any part of the Product except for archival copies of the computer software components of the Product as permitted by law; you may not reverse compile/assemble/engineer, modify, or incorporate in whole or in part in any other product or create derivative works of similar purpose of the Product based on all or any part of the Product; you may not extract, measure or take steps to numerically analyze, verify, identify, capture or reproduce contents of the Product for any purpose including but not limited to creating competitive products; you may not represent your derivative works (i.e. your recordings) using the names of locations, places or instruments of the Product; you may not remove any copyright, trademark, proprietary rights, disclaimer or warning notice included on or embedded in any part of the Product; you may not transfer or resell the Product unless permitted by local regulation or Entel beforehand. TERMINATION

The terms of this License shall be construed in accordance with the substantive laws of Hungary.

No Waiver

The failure of either party to enforce any rights granted in this Agreement or to take any action against the other party in the event of any breach of this Agreement shall not be deemed a waiver by that party as to subsequent enforcement of rights or subsequent actions in the event of future breaches.

Litigation Expenses

If any action is brought by either party to this Agreement against the other party regarding the subject matter hereof, the prevailing party shall be entitled to recover, in addition to any other relief granted, reasonable attorneys' fees and litigation expenses.

Unenforceable Terms

Should any term of this License Agreement be declared void or unenforceable by any court of competent jurisdiction, such declaration shall have no effect on the remaining terms hereof.
